- 2. Minute of April Meeting and Matters Arising
 - a. Minutes approved (with minor changes) and seconded
 - b. Matters arising: None
- 3. Police Update
 - Several thefts being investigated in area.
 - Continuing Operation Rowan to detect cars going through red light on High Street.
- 4. Wallace Tower presentation of project (Cllr. Ross Grant, George Douglas)
 - Tillydrone Development Trust set up in 2011 to identify projects with potential for regeneration, and after consultation determined that Wallace Tower to be converted to multi-purpose and flexible community space. After tendering process, appointed architect George Douglas who is also local resident to conduct feasibility report.
 - Modified original plans recently following review by Historic Scotland, who proposed avoiding anything that affects the integrity of historic building, which poses practical difficulties because the rooms in the tower are very small, but Historic Scotland concurred with creating a minimalist extension to building. Intend to house café on ground and 1st floors, as well as gallery on 1st floor overlooking Don Valley and office space on 1st and 2nd floors. Hoped that visitors to St Machar's Cathedral and other areas of Seaton Park will visit the Tower. To be staffed mainly by volunteers although Trust would consider hiring staff if necessary.
 - Some concern was expressed about parking since there will no parking along the road
 once the Third Don Crossing is built, but some customer parking is likely to be available
 opposite the Tower, according to Regeneration plans for housing on the Tillydrone side.
 - Will consult with Old Aberdeen Community Council since within Old Aberdeen boundaries, and Cllr. Grant proposes that OACC members sit on Development Trust.
- 5. Mobile food retail outlet ("Burger Van") proposed by University (CB)
 - University has withdrawn its application for a license, after numerous residents objected. OA councillors noted they only found out about the licensing application because a local resident chanced upon an item in *The Citizen*, which has no distribution

in Old Aberdeen. Professor Rodger has said he is unable to attend OACC meetings this month or in June, but hopes to attend a meeting in the months to come.

- 6. Proposed letter to ACC about communication (DM)
 - Draft of a letter has been agreed on, raising a number of issues about communication with ACC.
- 7. Draft Old Aberdeen Character Appraisal (DM)
 - DM noted that the document is poorly edited and, despite significant omissions. OACC proposed withdrawing the document in order to rewrite it.

8. HMOs (CB)

Cllr. Milne has reported that he is still waiting for a response from the relevant Council
officer to OACC's request for information about HMOs in Old Aberdeen. Cllr. Grant
promises to assist Cllr. Milne in this and, if the information is forthcoming, to invite
relevant Council officers for the 17 June meeting.

 Department.
